### Student/Participant Waiver and Release

(collectively referred to as the "AMG Companies"). Due to the structure of this program, there may be a break between courses. During that break, I acknowledge that I will not be part of the Program, that the AMG Companies have no responsibility for my safety or well-being during the break, and that I will be responsible for all of my expenses and costs of any kind during the semester break. In addition, I further acknowledge that during times when the courses I am enrolled in under the auspices of the AMG Companies are not in session or I am not attending such courses, the AMG Companies have no responsibility for my safety or well-being.

In consideration for the services that the AMG Companies are providing to me, I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless on behalf of myself and my heirs, assigns, and personal representative and estate the AMG Companies from any and all claims, demands, or causes of action which might arise during the semester break when I am no longer part of the Program or that might arise outside of the hours during which I am attending the course(s) being conducted by the AMG Companies.

I further acknowledge that I am solely responsible for all aspects of my safety and well-being: (1) until such time as the Program resumes after the semester break and I am back attending the Program; and/or (2) outside of the hours during which I am attending the courses offered as part of the Program. In the event all or part of the Program is being held in a foreign country, I represent and warrant that I fully understand that there are many risks associated with traveling and residing in a foreign country.

Should the AMG Companies or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. I further agree that if I file a lawsuit against the AMG Companies pertaining to any and all claims, demands, or causes of action that might have arisen during the semester break or for a cause of action which arose or accrued outside of the hours during which I was in attendance at the courses offered by the AMG Companies, jurisdiction and venue shall be in the First Judicial District of Alaska in Juneau, Alaska and that the law of the State of Alaska shall apply in such a lawsuit without regard to conflict of law principles of the State of Alaska.
